

**DEED**

THIS DEED is made on the \_\_\_\_\_ day of March, 2014

**BETWEEN:** Kasevich Yevgeniy Ivanovych ("KYI") and Kasevich Vira Viktorivna("KVV") ( jointly " The Individuals")

**AND:** Hillsong Church Ltd a company incorporated in Australia of 1-5 Solent Circuit, Baulkham Hills, NSW 2153, Australia (hereafter referred to as "Hillsong")

**RECITALS:**

- A. The Individuals were, until recent resignation, the Senior Presbyters of what is known as Hillsong Church Kiev, and Hillsong Church Moscow (jointly hereafter referred to as "HCKM");
- B. Hillsong and the Individuals have agreed, in principle, to resolve all issues concerning HCKM and Hillsong and wish to record the basis of settlement between them.

**NOW THIS DEED WITNESSES:**

- 1. **RESIGNATION:** The Individuals confirm their resignation from the position of Senior Presbyter of HCKM and will simultaneously sign the attached documents confirming their resignations and any other documents required to give effect to their resignations.
- 2. **VOLUNTARY DONATION AGREEMENT:** KVV has agreed to make a voluntary donation to Hillsong Church Kiev, being proceed of sale of the property identified in the attached Voluntary Donation Agreement ("VDA") to be signed simultaneously with this Deed and KYI consents to such donation and will also sign the VDA.
- 3. **RETURN OF CONFIDENTIAL INFORMATION & PROPERTY**  
The Individuals will return all property of HCKM including equipment, assets, financial instruments including cash or other instruments, databases and Confidential Information (as defined below) to HCKM and/or Hillsong, no later than thirty(30) days. The Individuals will prepare a list of all HCKM property and Confidential Information to be returned, which property includes, but is not limited to, the following in the possession of KYI:

The Individuals agree that they will not use nor retain copies of any Confidential Information and unless required by a Court order, disclose the Confidential Information or permit it be disclosed to any person, entity or corporation. Any Confidential Information held by the Individuals in electronic form will be delivered to Hillsong in such format as Hillsong shall direct.

Hillsong will liaise with the leadership of Hillsong Church Kiev to create a list of property of the Individuals, in the possession or control of HCKM and will arrange with the Individuals for a mutually convenient time for return of respective property and delivery of Confidential Information to Hillsong.

**4. CHURCH INVOLVEMENT:**

The Individuals undertake that they will not:

- i. At any time hereafter attend any service held at HCKM; however, their family is most welcome to attend church services.
- ii. Make any contact with any of the leadership, staff or key volunteers of HCKM; however, any conversation needed with staff, leadership or volunteers can be directed via Gary Clarke.
- iii. Do anything that would cause any disunity within HCKM.

**5. VISA APPLICATIONS:**

Hillsong has agreed to assist the Individuals and Kasevich Roma and spouse, to apply for the appropriate USA visas based on professional advice. Hillsong agrees, without admission of obligation, to pay associated costs, not exceeding USD \$10,000. Hillsong makes no warranty as to the success of these applications and the validity of this Deed cannot be challenged if the visa applications are unsuccessful.

6. **JOINT STATEMENT:** The Individuals and Hillsong will, at a time to be agreed, jointly prepare a statement for publication, relating to the decision by the Individuals to resign from leadership at HCKM and their future plans and each agrees it is not their intention, nor their desire, to publically disparage the other.

7. **GENERAL PROVISIONS**

a. Each party agrees to execute all such additional documents which may be necessary or desirable to give full effect to this Deed;

b. **Confidential Information** includes, but not limited to:

i. information relating to HCKM and/or Hillsong, which is reasonably regarded by the parties as confidential;

c. **This Deed:**

i. shall be governed by the laws of Australia;

ii. and the documents referred to is the entire agreement between the parties;

iii. and all its terms shall remain confidential and unless required by law, or to enforce, shall not be disclosed to any party other than legal representatives.

iv. has worldwide application in perpetuity;

v. and any provision of this Deed held by a court, with jurisdiction, to be unenforceable will be deleted from this Deed, without any negative effect to any other provision of this Deed.


