### STATEMENT OF PROBABLE CAUSE

On March 11, 2022, a 20-year old female (herein Victim 1) provided a statement to law enforcement where she disclosed being sexually assaulted by her pastor, BRUCE DOUGLAS KONOLD, dob:

(herein Defendant). For approximately 30 years, Defendant was a pastor of an Eagan church in Dakota County, Minnesota. Victim 1 began attending the church on January 31, 2021. After the first service, Defendant started regularly inviting Victim 1 to his Eagan home with other church members.

In February of 2021, Defendant brought Victim 1 out to his garage. Defendant told Victim 1 that he knew she needed a father figure and that he would like to be that for her. Defendant started providing spiritual counseling and guidance to Victim 1 on a regular basis. During Victim 1's college break in March of 2021, Defendant suggested that Victim 1 stay at their home. On March 10, 2021, Defendant provided Victim 1 several alcoholic drinks. Victim 1 was underage at the time and had never consumed alcohol. Victim 1 recalls feeling foggy and had difficulty walking. Defendant suggested that they watch television. While Victim 1 was sitting on the couch, Defendant started touching the outside of her genitals. When Victim 1 tried to go to bed, Defendant followed her into her bedroom and tried multiple times to remove her clothing. After Victim 1 pushed Defendant away several times he finally left. Following that incident, Defendant started to regularly message Victim 1 sexual messages.

Towards the end of the 2021 school year, Defendant suggested that Victim 1 move into their home and obtained her a cleaning job at the church. On May 27, 2021, Defendant vaginally penetrated Victim 1 for the first time. Defendant then started regularly engaging in sex acts with Victim 1. The acts including vaginal penetration, digital penetration, and oral sex. The acts occurred at Defendant's home, the church, Defendant's vehicle, and hotels. The acts continued regularly until December of 2021.

Victim 1 described conflicting emotions about the incidents explaining that there were certain incidents that didn't feel consensual. Defendant began telling Victim 1 that if she ever came forward about what was happening that it would be because she hated him or wanted to destroy him. Defendant started regularly making comments about him wanting to commit suicide and would send photos of him holding his gun and several times brought his gun with him while he was driving Victim 1 around. One time, Defendant told Victim 1 "what if we both just died and that would take care of it."

In December of 2021, Victim 1 stopped attending the church after Defendant's wife, of Minnesota approached Victim 1 and told her to never show her face again at the church and to disappear completely.

On March 1, 2022, T.K. sent Victim 1 the following message: "Bruce told me everything. I already knew lots of it. His phone is shut off and he will no longer respond to you. I suggest you find someone to help you through this. Do not contact me or MY husband."

On March 9, 2022, a 30-year old female (herein Victim 2) contacted the Eagan Police Department to report a sexual assault. On March 15, 2022, law enforcement spoke to Victim 2 who reported the following facts. Victim 2 and her husband attended Defendant's church for approximately 10 years. In 2020, Defendant offered Victim 2 a personal assistant position at the church.

On June 22, 2020, while at Victim 2's home, Defendant told her he was smitten with her. While they were seated on the couch, Defendant reached up under Victim 2's clothing and started rubbing her breasts. After Victim 2 told Defendant that they each should work on their respective marriages, Defendant left.

Soon afterwards in November of 2020, Defendant started pressuring Victim 2 for a kiss and later for sex. Defendant starting begging Victim 2 not to leave the church or tell the church elders. Defendant started making suicidal comments when Victim 2 would reject him. Defendant would text Victim 2 that he was looking for sharp knives in the kitchen or staring at his loaded gun at the church office or at home. Defendant told Victim 2 that she was selfish because he had been meeting her emotional needs, but she was refusing to meet his needs.

After promising to leave Victim 2 alone afterwards, she agreed to have sex. Victim 2 and Defendant met at a hotel out of town on November 23, 2020 and had sexual intercourse.

Later that same month, Defendant and Victim 2 went hunting. While on the way to the hunting cabin, Defendant pulled the vehicle over and Defendant and Victim 2 had sexual intercourse for a second time. While at the hunting site, Defendant and Victim had sexual intercourse for a third time.

Victim 2 described numerous instances of sexual contact including Defendant fondling Victim 2's genital areas. These instances would usually occur in Defendant's vehicle around the area of the church, in Lebanon Hills park, a dirt road in Rosemount, and in the Victim 2's home. The acts continued until January

of 2021. During the time of the acts, Victim 2 continued to regularly meet with Defendant for one-on-2016/2022 spiritual counseling and guidance.

On March 27, 2022, law enforcement spoke to Defendant. Defendant admitted engaging in a sexual relations with Victim 2 approximately 15 times between November of 2020 and January of 2021. Defendant admitted engaging in sexual relations with Victim 2 at both Victim 2's home and on the hunting trip. Defendant expressed concerns about the church supporting Victim 2's current mission work saying that "it was not right that they continue to support an adulteress" and quoted a bible verse regarding adulterous women being "stoned."

Defendant described his relationship with Victim 1 as "another adulterous relationship" and stated that he had sexual intercourse with her over 100 times during a 9 to 10-month period. Defendant did not answer the question of whether he considered Victim 1 as someone seeking spiritual counseling directly but admitted that Victim 1 thought of him as a father figure and explained that his conversations are spiritual given that he is considered one of the foremost experts in world religions.

On April 6, 2022, Victim 1 left a message for law enforcement indicating that she had felt pressured to come forward and was no longer sure about whether she had been sexually abused.

On April 29, 2022, Victim 1's pastor, R.P., contacted law enforcement and stated that Defendant had been aggressively pursuing Victim 1 by showing up at her home, work, and school. R.P. explained that Defendant has been leaving Victim 1 notes and texting her constantly. R.P. reported that Defendant has been using threats of suicide to manipulate Victim 1 into continuing a sexual relationship.

Law enforcement then spoke to Victim 1 who confirmed that Defendant had been regularly harassing her after learning about the police report. Victim 1 described an incident where Defendant approached her car and asked why she wanted him to go to jail and kept talking about how he had lost everything. Defendant told Victim 1 that she could tell the police that it wasn't abuse. Law enforcement contacted Defendant who admitted being in contact with Victim 1.
