This is my last email

I have been in and out of meetings since I left you at 10am today.

I am sorry, I am not clear minded right now and I am exhausted but I am still swirling and hurting

I just wanted to clarify that when I wrote in my last email a some hours ago saying this was "my most painful day"

- 1. I do not mean painful because of her conversation with you I am okay with you in the conversation I trust you and your ways
- 2. I do not even mean because others (including me) would be greatly hurt, if... blah blah blah

However, I cannot imagine the relational anguish and confusion it would cause in the multi-level long term sovereign relationship with IHOP and

What is painful is the thought of others being told a certain narrative that is not the narrative I believe that God has and then they will pass it on—that would constitute the greatest betrayal of my life from one my dearest friends who I have trusted 100%. It would be a far worse betrayal than what Ernie Gruen did to me in 1990—far more personally painful and relationally destructive.

I realize that she has not **betrayed** me at this point (so forgive me using such ugly language "as betrayal") but even the chance of her doing this **creates great pain in** me (but not anger at her)—that a most trusted friend did this to me at the end of my life after 40 years of being in prayer meetings many hours a day (6 days a week)

I told you about the prophetic dream 2 years ago (?) that I had from Psalm 55:12-14 - I have prayed many times to bind the demonic powers that would energize this painful betrayal.

In my last meeting with Ernie **before** he spoke against me in 1990, he told me that he had a prophetic dream to expose me and that he had it 3 times. (Of course, I had the Michael the archangel encounter in Sept 1984 and Michael showed the rage of Satan striking me through Ernie when "I went to the east"). Thus, without telling that to Ernie, I just urged him to be slow and to **be careful to hear God** before he acted on those 3 dreams **because I knew 100% that it was the rage of Satan breathing on his mind**.

"I went the east" in December 1989 and the next month Ernie attacked me publicly in January 1990 just as Michael the archangel showed me in Sept 1984

In April 2023 the Lord make it 100% clear to me that was "I again going to the east" in May 2023 with

5 million praying for Israel and the Black Horse would strike me again with the rage of Satan after May 2023

I am **NOT** saying that Satan's rage is coming through talking to you - but the hot fire of his demonic breath will come on the minds of some who will be energized to distort even what they hear from people quoting and then Satan will energize them to pass it to multitudes via social media, etc

If this escalates, I am sure many will conclude Satan's rage was coming through **But** that is **NOT** my view

But I would never say anything negative about but only words of blessing on her and I would do the same even for those who share and distort her narrative.

Satan's raging accusation *is impossible to control* because he has a supernatural ability to accuse by inflaming distortion and anger in the minds of people, even good people.

I plead with you and as two of my most dear long term trusted friends to ask the Spirit to show you His narrative of my life and what He sees and says about me and ask Him to give you peace or whatever -

## I am sure He will

If me, you, or miss Him on this it would be one of the worst decisions of our life. Yes, I include "me" in this statement —"I have to see what He sees and only say what He says" in this.

If by chance **she has whispered this** story to any others—the evil result that enemy wants in this **can still avoided**—if she will **only speak His narrative** to any who might ask her about this in the future by simply saying only what the Spirit told her, it might be something like **"I have peace that the Lord is...** blah blah" -

That sort of approach would cuts off the Black Horse inflaming distortions and exaggerations and many false narratives in peoples minds.

I have not **sworn before God** to another person more than 2-3 times in 50 years.

But I will do this one time and only to you.

Before God, I assure that there is NOT of one (of these named ladies) that I told that God showed me Diane would die so that I would blah blah with them (I cannot even type something as horrible as this).

If you will insist that these ladies come to me (even to just email me if they do not to talk to me in person) and let me respond.....I am very confident that I will not get even one email - this is inconceivable to me that someone said that about me. The implications for me to have said that would be HORRIFIC and EVIL.

It is a terrible injustice to my relationship with you and for the narrative of unnamed ladies to be inserted into this conversation (when they have never told me this and never will). Our relationship is far valuable and sovereign to let unnamed voices insert horrible things like this in our relationship - UGH!!!

Matthew 18:15 requires that they come to me to win me to repent of a sin that I am continuing in

I asked you what is the redemptive take away for this is and you said "that I repent" -

I do not remember in 50 years of ever going to bed at night without having repented of any conscious breach with God from that day. I really love Jesus. I have already sincerely repented of everything that I did a week ago, and a year ago and a decade ago etc. Meaning, I never let a conscious sin go without repenting that night.

So what specifically is it that wants me to repent of—or to stop doing? I am not aware of doing anything sinful that I need to repent of—but I always ask Him just in case.

In my many years of ministry, I have seen many who want revenge and punishment—not repentance to win a person to follow Jesus with a clean heart - that is what Matthew 18:15 calls us to

I hope, I never get asked about this story by others but if I do I will never give any details but I will only and always say the truth that "I am very confident in the divine narrative about those years—that I have God's pleasure with many tokens of His favor to confirm it (His pleasure on me from those early years and also in the many years since then) and that I am confident the He will vindicate His pleasure of my life (without me ever defending myself).

God's narrative over my life is His pleasure over my life from those years. I have never been blameless in 50 years of walking with Jesus but as we embrace the bridal paradigm then we "push delete" and move on with confidence in His delight - that is the Song of Solomon and Hephzibah message of Isa. 62:4. This is our message to the nations.

The Lord has told me on at least 5 supernatural encounters to not vindicate myself but let Him do it in His time so I will continue to do this as I have for 40 years - I would say the same thing I said to Ernie and an number of others - I will not take revenge or vindicate myself but I will let the Lord decide 1 Sam. 24:12-15 that has proven very effective for me over 40 years. That is the only posture that I will take with this as well as with many more hits from the Black Horse in the future.

I am very aware that Satan (the dragon/black Horse of Rev. 12:10) will use his supernatural ability to inflame accusations against me, you, and many others who will get involved in this. He wants all of us to be destroyed. Satan is an expert at taking whispered innuendoes and turning them into hostile accusations.

And he will use social media to spread accusation based on distortion to multitudes but worse—he will make them it part of the *permanent record* for decades that all of our children and grandchildren will read

Satan will not just do this about what might say or what I might say. But also about what many will add and exaggerate in others stories that will emerge out of the social media conversation on this and it will unnecessary harm to so many—including us and our children

I saw this with the Ernie Gruen thing - it was chaotic and many relationships were injured in the multi-layers of accusations (all that was before social media). **The enemy convinced him that he was being heroic** but in fact he was being used in a very terrible way—and he so regretted it later.

If this story got to social media

- 1. Many will come to my aid
- Many will come to said
- 3. But know that the 10+ who over the years have vocalized to me their strong negative views about getting away with speaking about people in harmful ways. A few will surely speak up—they will assume it would be righteous to finally "put in her place". She is really unaware of how energize a few of them are. I could give you several examples of this but I will only mention one—those who felt was horribly mistreated by what said about him—they are convinced drove him out of IHOP I am know of one or two of them who will speak out on this on social media -

yes they will claim that they are **only** defending MB but in really it will **also be** because they have had long term unhappiness **that got away with the unjust treatment of the who they cared about.** Satan will inspire lies to be told about related to this story because Satan will breathe on all of the sub-plots that will emerge.

Consider urging her to **not** embrace the "false heroic paradigm" of what some many encourage her to do. **It will bring far more pain than affirmation** to and your family. This sort of thing will go on and on **until so many of us are hurt**.

I will also do whatever I can to help you and in these or other situations - you can trust me to do that. I truly have fully bought into Ps. 18:35 and Zech 3. But social media will not be controlled by me so multitudes will attack her and me for different reasons mostly those based in their own pain and negative stories.

I have maybe 100 (?) emails from several from each of the last 25 years in which she gushes on how helpful I have been to her in many ways and how righteous I have been—but now suddenly she dramatically switches her story.

Of course, I will share **NOT** all those 100 email with anyone but Diane (and possibly Stuart if things escalate).

Diane will be very angry, greatly pained and deeply embarrassed especially in having known the story for years. She has wondered why got a free pass. Diane has loved and related to family for many years. She would take it very personal that would say things that would clearly know would cause great pain to our family. So I got a feeling she might share some of these email with a few family members—they will also be very angry at so I imagine they will want to set the record straight that is...blah blah blah - it is human nature. In other words, those emails will probably get on the social media. I hope not, that is not my style at all. But even in all of this I will only bless and I will never seek revenge nor will I ever defend myself

I will send you an email after this that 50+ IHOP leader got some years ago - It is an email with my favorite prophetic dreams.

Here is set s part of that email

Dec 19, 2012—prophetic dream about Psalm 89 for MB

My dream opens with me talking to MB. Our conversation is warm and friendly but suddenly turns into intense. In the dream, I placed my hands on his shoulders and say "you are the chosen leader of this movement. You are the most righteous man. God has made a covenant with you. I begin quoting Psalm 89 (v19-28).

I had understanding that God made this covenant with MB and MB with Him in 1997 & 1998 and that it was related to FOTB. I prayed with authority, "His covenant He will not break, He has sworn by His holiness, you are David and He will establish that which He promised.

You are His chosen, you are the righteous leader He has chosen. I had weight in my words. As I was prophesying it was like prophetic intercession like you were transitioning into something new related to this covenant. The other specific phrase I quoted was v. 27 "I will make him my firstborn, the highest of the kings of the earth". There was

tremendous attack coming against MB and His covenant with God like David. I woke up with tremendous presence on me. I felt like I wrestled thru the night because the dream was so intense. I felt both great light but also the powers of darkness that were against MB. Every time I spoke about this covenant I felt the authority of God coming against evil assignments.

Satan as the Black Horse for Rev. 12:10 accusation - will make sure every story will have maybe 5-10 different narratives that people will can pick from—all of them will have dark distortion and exaggeration in them.

Many IHOP staff (current and thousands over the years) will be **embarrassed and even very angry** to hear such horrible stories about me - one reason is because their
critics will attack them with these stories and will promote any number of the distorted
negative stories that will emerge on social media - it will be nightmare

Humbly, I would not be able to keep my commitment to send you monthly support (not because of being angry, I will always love and seek to bless you and your children) but because others would surely find out and it would appear that I was trying to bribe you and someone will surely put that on the social media and then many will make more horrible comments about me trying to bribe you. I hate that I will not be able to support you financially or to use you to help distribute finances to key house of prayer leaders in the nations as planned.

I know the Lord will take care of you and I am sure that you do not need me to help. (After a few year I will try to figure out a way to get you some support). I will never change my commitment to help you and and your children. My commitment to you is from the Lord and it is very precious to me

As I said, as of now I still want the 3 of us to labor together in a deep way in the nations

My role would be mostly proving finances, making handouts and connecting you to many others and being a prayer covering for your family) - "it is not too late for that to happen"

I still believe in you and and I will want to go forward and I want to bless your family MUCH

I would be hurt but never angry at and I will always be gracious to her from my heart I will always be an advocate for you and her to others—even in the midst of the 5-10 scenarios what would surely rise up to trouble you and your family—I assure you that you do not have all the info on these.

I am not being secretive, I was just not prepared today for this

I know I am rabbling right now because of how I feel physically and emotionally. But I wanted to jot a few thoughts down so you have them in your mind before we meet again

I prefer to not have go over each one again in person but I will if needed. I have much more to share.

I was so shocked today that I could not be as clear as I wanted - I was totally spinning and as I told you—I had a low grade fever this morning.

Again, what is the redemptive take away from all of this that will inspire humidly, love and obedience to Jesus and more? I can not see anything redemptive just long term pain and many really hurt relationships HELP LORD

I never did tell you the 2-3 things that I wanted to share with you about other topics Again, today I appreciate the privacy you provided for me in meeting me alone and for your kind tone today
