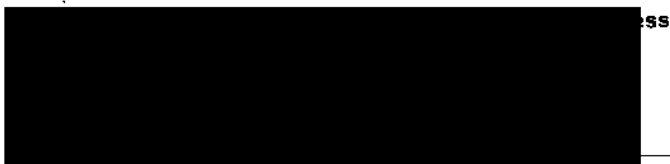

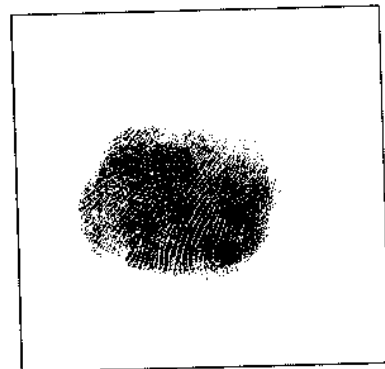

Before me the undersigned Judge of the Fourth Judicial Circuit, in and for Duval County, Florida, personally came Detective D.L. McLennon 76099 who, being duly sworn deposes and says that she has reason to believe and does believe that one **Vernon Williamson**, described as follows: Last Known Address: **2401 Village Lane Apartment H2, Ardmore, OK 73401** Race **White**; Sex: **Male**; DOB: **09/17/1936**; Ht: **6'1"**; Wt: **165** pounds; Hair: **Salt & Pepper**; Eyes: **Blue**; Scars, Marks: **N/A**; did in Duval County, Florida, between August 13, 1996 and August 13, 2001 commit the crime(s) of **Capital Sexual Battery**, contrary to the provisions of Section(s) **794.011 (2)(A)**, Florida Statutes. Affiant's reasons for so believing are as follows:

Your affiant has been employed with the Jacksonville Sheriff's Office as a Police Officer for six (6) years and is currently assigned to the Special Assault Unit. Your affiant has been handling Special Assault cases for three years.

On September 16, 2020, the Jacksonville Sheriff's Office was notified of multiple sexual battery and child abuse incidents that occurred involving suspects and victims affiliated with a church called The Jacksonville Assembly of the Body of Christ located at 6350 Old Kings Road, Jacksonville, Florida, 32254 (Prior to 1995, the Church was originally located at 6858 Old Kings Road, Jacksonville, Florida 32254). The sexual battery incidents allegedly occurred over several years that spanned from 1976 to 2001. The current head pastor of the Church was Paul Dyal, who was also head pastor during this time frame.

During the preliminary investigation, it was discovered that on June 11, 2019, law firm Cohen, Milstein, Sellers, and Toll PLLC sent a demand letter to The Jacksonville Assembly of the Body of Christ and to Paul Dyal individually. The letter was on behalf of several victims who disclosed sexual, physical, and emotional abuse that occurred within the Church when they were minor children. The law firm received no response from the Church.

One of the child victims, [REDACTED] (DOB [REDACTED] now [REDACTED] years old, [REDACTED] to [REDACTED] years old during the time frame of the incidents) disclosed that she was sexually battered multiple times by the suspect, Vernon Williamson (DOB 09/17/1936, now eighty-five years old, approximately sixty-one to sixty-three years old during the time of the incidents).

Further research revealed that on June 17, 2008, [REDACTED] reported the sexual battery incidents to the Jacksonville Sheriff's Office (2008-589030). [REDACTED] disclosed that Vernon Williamson (herein after suspect) was [REDACTED] at that time while living on the Church's property. Her mother (who was deceased when [REDACTED] reported the sexual abuse) left her in the care of the suspect. On numerous occasions, between the ages of [REDACTED] and [REDACTED] years old, the suspect digitally penetrated the vagina of [REDACTED] and forced her to masturbate him. [REDACTED] disclosed the sexual battery incidents to her then pastor at the Church, Paul Dyal, in 2004. During an interview with JSO in 2008, Paul Dyal admitted that [REDACTED] told him about the sexual abuse from the suspect. However, he stated he did not believe [REDACTED]. He also admitted he should have reported the sexual abuse, but he did not. The suspect

denied the sexual abuse allegations during an interview with law enforcement; the investigation was suspended at that time.

On February 19, 2022, your affiant made contact with [REDACTED] in person at her residence for an interview. [REDACTED] stated that both of [REDACTED] met in Paul Dyal's Church and eloped. Their relationship did not work out and [REDACTED] brought [REDACTED] and her three brothers back to Paul Dyal's Church in Jacksonville. At that time, [REDACTED] and her brothers were living with other families in the Church but eventually moved into a trailer that was located on the suspect's property. [REDACTED] was approximately [REDACTED] years old at this time. The suspect would take care of [REDACTED] and her brothers during the day while their father was working.

The sexual abuse started by the suspect when [REDACTED] was [REDACTED] years old. The sexual abuse incidents started with the suspect committing acts of lewd or lascivious molestation at first. Specifically, [REDACTED] detailed that the suspect would bathe and dress [REDACTED] and touch her. The suspect would touch her body over her clothing and would make her sit on his lap and "he would become excited," referring to the suspect becoming erect. The abuse progressed and the suspect started telling [REDACTED] that if she loved him, then she would have to touch him on his penis and he would show her how.

Approximately a year later, the touching progressed again to "actual rape" as described by [REDACTED]. The suspect started showering with [REDACTED] and then forced her to perform oral sexual intercourse on his penis and the suspect would put his mouth on [REDACTED] vagina. These incidents occurred when [REDACTED] was [REDACTED] years old.

When [REDACTED] was approximately [REDACTED] years old, she stated that the suspect forced his penis into her vagina and [REDACTED] stated, "it was full penetration." [REDACTED] stated that such acts occurred on multiple occasions. She denied the suspect forced any penile/anal sexual intercourse. The suspect also took multiple photographs of [REDACTED] and would force her to wear a diaper and nothing else. The suspect kept the photographs and would threaten [REDACTED] that he would use them against her if she said anything about the sexual abuse. The suspect made multiple threats to [REDACTED] including that if she ever told on him, her brothers would be taken away from her. The suspect also told her that he "did not want to hurt her or them (meaning her brothers), so do not tell anybody."

[REDACTED] stated she was always very scared. When she was [REDACTED] years old, [REDACTED] had multiple urinary tract infections (UTIs) that were left untreated, and she would frequently urinate on herself and the bed. After several times of [REDACTED] wetting herself during school hours, one of [REDACTED] Brenda Humphrey, noticed and asked [REDACTED] what was wrong. [REDACTED] disclosed that the suspect was "touching" her and that he was putting cream/lotion on her because of her rashes on her vaginal area. Brenda Humphrey told Paul Dyal's wife, Catherine Dyal, about the sexual abuse committed by the suspect on [REDACTED]. When this abuse was made known to Paul Dyal, [REDACTED] and her brothers were separated and sent to live with other families in the Church, which was what [REDACTED] feared would happen if she disclosed what the suspect was doing.

[REDACTED] stated that although Paul Dyal knew of the sexual abuse committed by the suspect on [REDACTED] he permitted the suspect to stay in the Church and continue to have access to multiple children. It was not until [REDACTED] disclosed to Gracie Lee Anderson (who she was living with at the time) about the sexual abuse that the suspect was sent away from the Church when [REDACTED] was approximately [REDACTED] years old.

All of the above instances of sexual abuse occurred in Duval County, Florida.

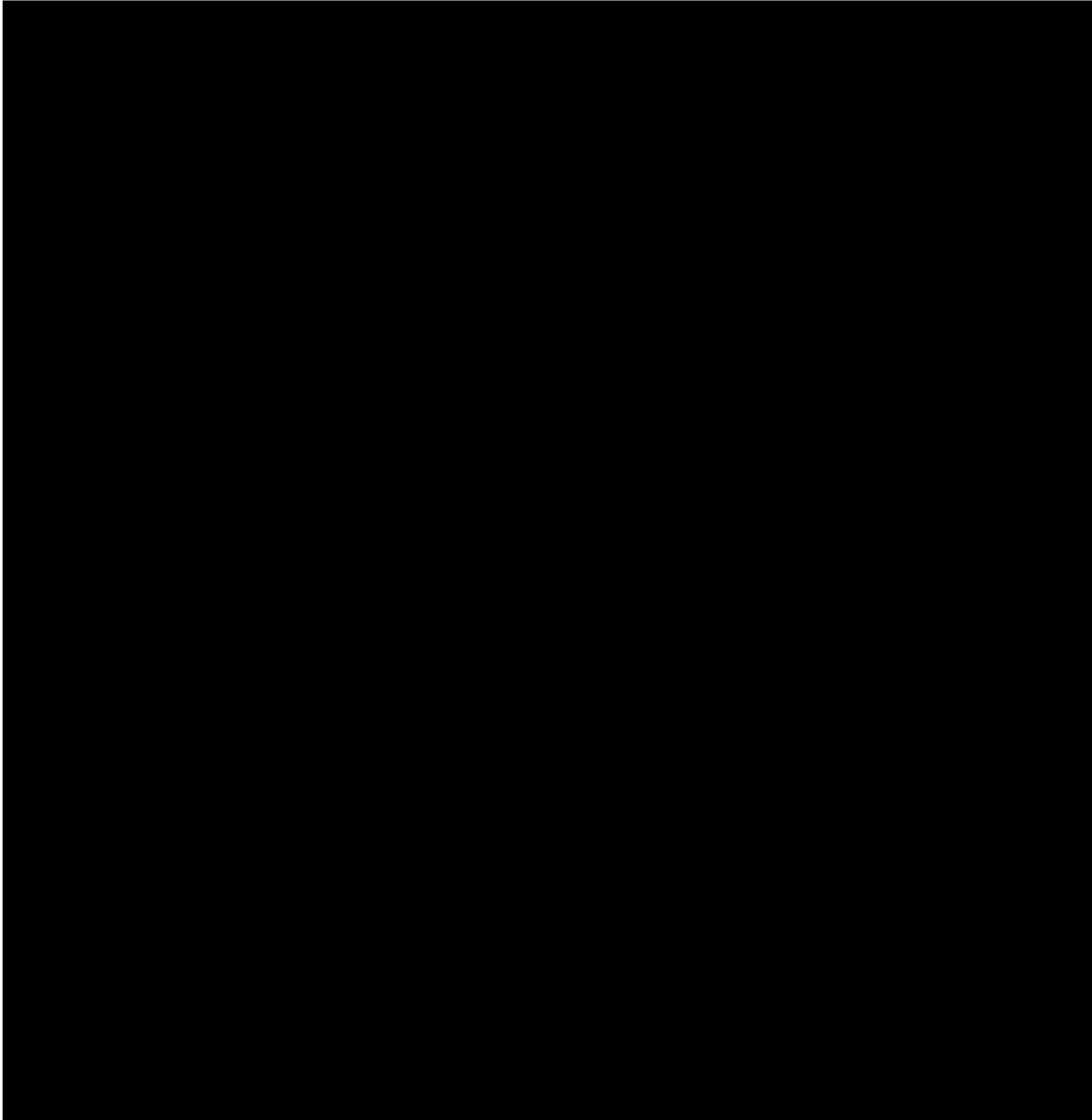

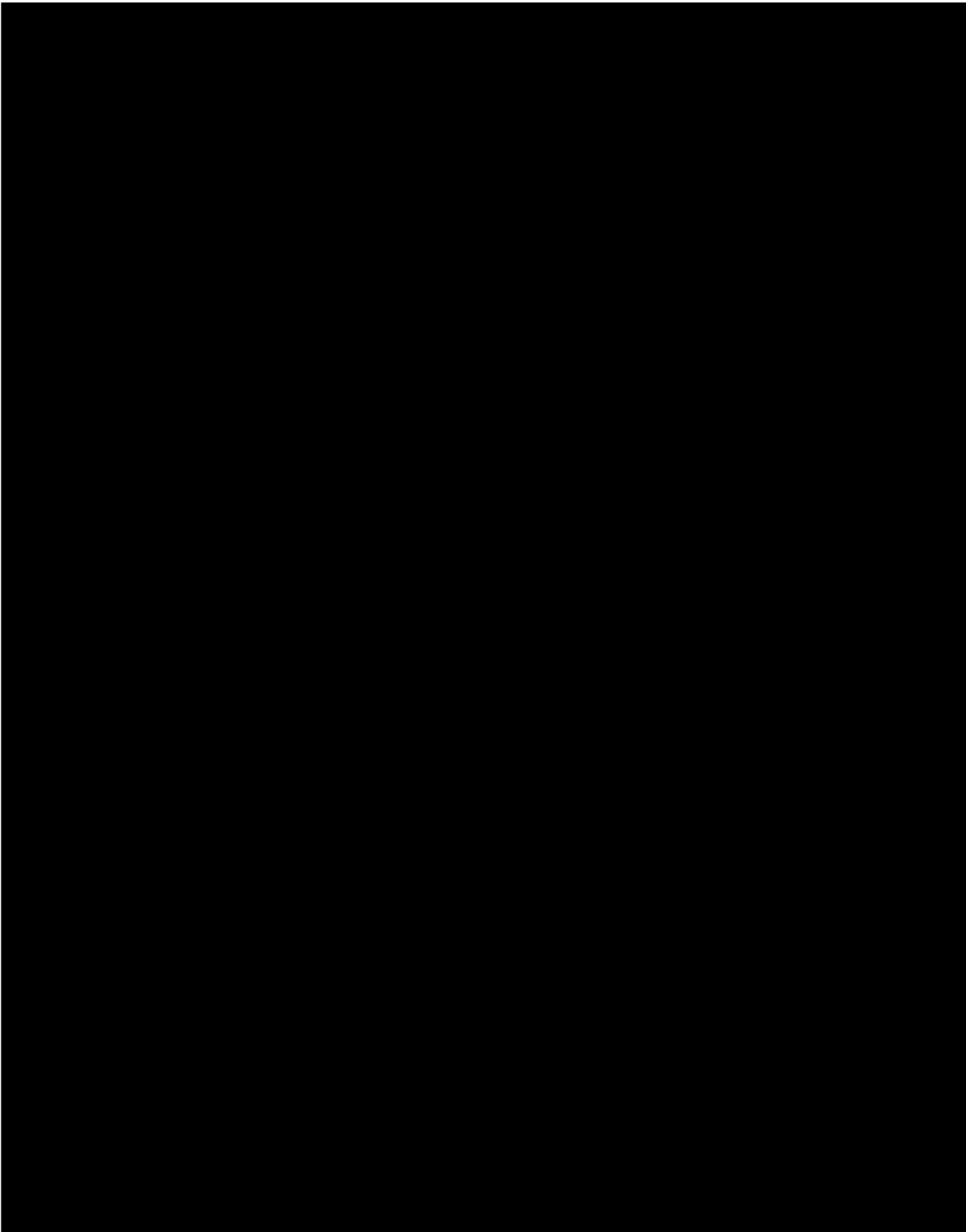
