

Your affiant has been employed with the Jacksonville Sheriff's Office as a Police Office (s) (6) years and is currently assigned to the Special Assault Unit. Your affiant has been handling Special Assault cases for three years.

On September 16, 2020, the Jacksonville Sheriff's Office was notified of multiple sexual battery and child abuse incidents that occurred involving suspects and victims affiliated with a church called The Jacksonville Assembly of the Body of Christ located at 6350 Old Kings Road, Jacksonville, Florida, 32254 (Prior to 1995, the Church was originally located at 6858 Old Kings Road, Jacksonville, Florida 32254). The sexual battery incidents allegedly occurred over several years that spanned from 1976 to 2001. The current head pastor of the Church was Paul Dyal, who was also head pastor during this time frame.

During the preliminary investigation, it was discovered that on June 11, 2019, law firm Cohen, Milstein, Sellers, and Toll PLLC sent a demand letter to The Jacksonville Assembly of the Body of Christ and to Paul Dyal individually. The letter was on behalf of several victims who disclosed sexual, physical, and emotional abuse that occurred within the Church when they were minor children. The law firm received no response from the Church.
