

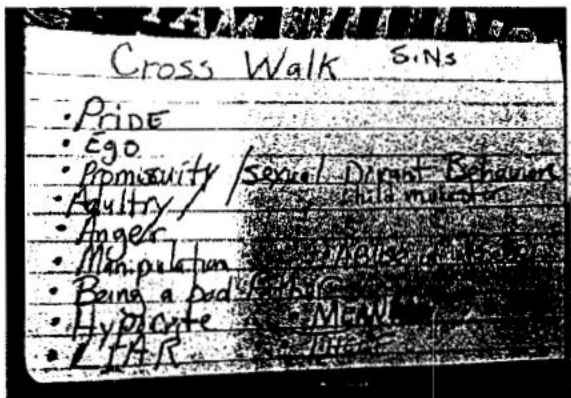

AB also provided further proof in the form of a handwritten list of sins that the defendant sent to her when he was at a men's religious retreat.



The defendant also sent AB a string of emails between he and his therapist, who after learning of the sexual abuse, told the defendant that he needed to report it. In the email chain the defendant tells his therapist that he understands his legal duty to report child abuse but that he felt tricked and thought that he was safe to disclose in therapy.

AB advised me that the defendant admitted to his crimes to the Deacons and Deaconesses at the church he pastored at. The defendant stepped down from his position as pastor over the weekend.

Prior to coming in to interview with me, HBO made a Facebook post telling the story of her sexual abuse at the hands of the defendant. HBO tagged the defendant in the post. In the comments, at least one other victim has come forward with allegations of sexual assaults committed by the defendant. That investigation is still ongoing.

According to AB, the defendant has been making "money moves" and has been talking about selling their house immediately. AB is concerned that the defendant may be planning to flee the state soon as he has family in Texas.

The defendant, Bertheophilus Bailey, knowingly began engaging in sexual acts with his biological daughter when she was in the sixth grade. The defendant made lewd and indecent proposals to his daughter when she was under the age of sixteen. The defendant touched his daughter's body in a lewd and lascivious manner. The defendant forced his daughter to touch his private parts. The defendant vaginally penetrated his daughter with his penis when she was approximately sixteen years old. The defendant went into this daughter's residence without consent or invitation and forced his genitals into his daughter's mouth just after she gave birth in 2021. The defendant is responsible for incest, lewd molestation of a minor under sixteen, first-degree rape, and forcible oral sodomy, and first-degree burglary.

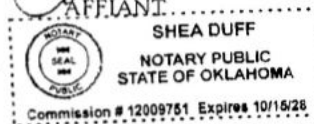

FINDING OF PROBABLE CAUSE


