BE IT REMEMBERED:

That **Stephen A. Kunzweiler**, the duly elected and qualified **District Attorney for Tulsa County, Oklahoma**, who prosecutes in the name and by the authority of **The State of Oklahoma**, comes now into the District Court of Tulsa County, State of Oklahoma, and gives the Court to understand and be informed that:

(COUNT 1)

21 O.S. 1114(A)

BERTHEOPHILUS MAURICE BAILEY SR, on or about August 15, 2012 through September 6, 2022 in Tulsa County, State of Oklahoma and within the jurisdiction of this Court, did commit the crime of **Rape - First Degree**, a Felony, by unlawfully and willfully, with the use of force and violence or by threats of force or violence accompanied by apparent power of execution, to one HB, a person not the spouse of said defendant: rape, ravish, carnally know and have sexual intercourse with said HB against her will and consent.

(COUNT 2)

21 O.S. 843.5E

BERTHEOPHILUS MAURICE BAILEY SR, on or about August 15, 2012 through September 6, 2022 in Tulsa County, State of Oklahoma and within the jurisdiction of this Court, did commit the crime of **Child Sexual Abuse**, a Felony, by unlawfully and willfully or maliciously sexually abusing HB, a 12 year old child, by inappropriately touching her. .

(COUNT 3)

21 O.S. 885

BERTHEOPHILUS MAURICE BAILEY SR, on or about August 15, 2012 through September 6, 2022, in Tulsa County, State of Oklahoma and within the jurisdiction of this Court, did commit the crime of **Incest**, a Felony, by unlawfully and willfully carnally know and have sexual intercourse with one HB a female person, said female being then and there the father of said defendant.

(COUNT 4)
21 O.S. 888(A)

BERTHEOPHILUS MAURICE BAILEY SR, on or about August 15, 2012 through September 6, 2022 in Tulsa County, State of Oklahoma and within the jurisdiction of this Court, did commit the crime of **Forcible Sodomy**, a Felony, by unlawfully and willfully, with the use of force and violence and by means of threats of immediate and great bodily harm to one HB commit the detestable and abominable crime against nature with the said HB by then and there having forcible, unnatural and carnal copulation per mouth with the said HB.

(COUNT 5)
21 O.S. 1114(A)

BERTHEOPHILUS MAURICE BAILEY SR, on or about April 1, 2013, in Tulsa County, State of Oklahoma and within the jurisdiction of this Court, did commit the crime of **Rape - First Degree**, a Felony, by unlawfully and willfully, with the use of force and violence or by threats of force or violence accompanied by apparent power of execution, to one MB, a person not the spouse of said defendant rape, ravish, carnally know and have sexual intercourse with said MB against her will and consent.


(COUNT 6)
21 O.S. 1431

BERTHEOPHILUS MAURICE BAILEY SR, on or about January 1, 2012, in Tulsa County, State of Oklahoma and within the jurisdiction of this Court, did commit the crime of **Burglary - First Degree**, a Felony, by unlawfully, willfully and burglariously, break and enter into a certain dwelling house occupied by and in the possession of MB and located at in the City of Tulsa, Tulsa County, Oklahoma, and in which there was at the time and place a human being, to-wit: MB, by pushing himself in said dwelling house and entering without the consent of said occupant, with the unlawful, felonious and burglarious intent then and there to commit some crime therein.

Contrary to the form of the statutes in such cases made and provided, and against the peace and dignity of the State.
