Affiant, having first been duly sworn according to law, swears that they believe, and have good cause to believe, that the individual named above committed the alleged offense(s) based on the following Summary of the Statement of Facts in Support of the Probable Cause:

On December 8th of 2024 at approximately 2300 hours I, Deputy Martin FC534 was dispatched to a domestic violence call at the residence of 6523 Clay CT in Canal Winchester Ohio.

Upon my arrival at the residence, I heard screaming inside the house, I then thought someone was getting attacked or assaulted so I entered the house to see what was happening. Once I entered through the door a male who was identified as Joshua Lough was running down the stairs. I then had Joshua step outside of the house to explain what was going on in the house between him and his family. Joshua stated that his wife has a mental issue and that's why they were arguing. I asked Joshua if anything physical happened tonight during the incident. Joshua said that he didn't hit anyone they just grabbed each other.

I was advised by Deputy Griffitts FC533 to detain Joshua until further notice due to the visible marks on her body. I then had Joshua stand up and places his hands behind his back so I could put my handcuffs on him. I double checked for the cuffs being too tight and double locked them so they wouldn't tighten up on him.

I spoke with 7.11, Joshua's daughter and she advised me that she was the caller and was in the basement at the time when the incident occurred. The stated that she heard a loud bang on the ground upstairs. Trinity then went to investigate what the noise was and saw Joshua grabbing his wife. They then slapped Joshua to release him from grabbing his wife. Joshua then slapped 1 11, and she called Fairfield County Sheriffs Office to report the incident.

Finally, after the investigation it was found and stated from Joshua's wife and daughter that he hit her and left the visible marks on both of there bodies. Joshua was then taken to the Canal

Winchester Sub station for processing and then transported to Franklin County Jail without any further incident.

Body worn camera was activated.
