That **LINDSEY ALDY WHITESIDE**, Late of the County and State aforesaid, between the dates of May 14, 2024 and November 6, 2024, in the County and State aforesaid, and within the jurisdiction of this Court, did willfully, unlawfully, feloniously, intentionally and knowingly engage in sexual penetration with M.F., a child less than eighteen (18) years of age, by placing her finger in the vagina of M.F. and/or engaging in cunnilingus by touching her tongue to the vagina of M.F., at a time when **LINDSEY ALDY WHITESIDE** was in a position of trust or authority over the child, in direct violation of Section 97-3-95(2), Mississippi Code 1972 Annotated, as amended, contrary to the form of the statute in such cases provided, and against the peace and dignity of the State of Mississippi.


