INFORMATION:

On 12/2/2024 at approximately 1530hrs, I was dispatched to call Clix at [REDACTED]. Clix told dispatch that he was meeting a pedophile at A&W at 1600hrs who is in his 40s and believes that Clix is a 16yr old. The target's name was only known as Marc.

CONTACT WITH CLIX:

I called Clix (later discovered to be Samuel Jeffrey Hall) and referred to as such for the remainder of my report). HALL stated that he does a YouTube channel about catching a predator. HALL stated that he decoyed as a 16yr old and is meeting up with an older male to have sex. He said that they were meeting at the A&W in Mason. He was requesting an officer to be there. I informed him that the police would need evidence before they acted upon an arrest. HALL stated that he would turn over evidence when the police arrived including naked pictures of the male's penis and buttocks as well as texts about the meet. I asked HALL if he knew where the suspect lived. He said that he did not. I tried to explain jurisdiction and proper evidence that would need to be obtained for any action to be taken by the police. I advised HALL that the police would not partake unless more information and evidence is provided beforehand. HALL then said that he would just call 911 then he hung up.

HALL requested another call from the police. I advised Chief Shutes of the situation and he spoke to HALL on speaker in my presence. Chief Shutes explained the evidence that needed to be produced to the police prior to a meet with the alleged suspect. HALL said that the suspect was a [REDACTED] in his [REDACTED]. The suspect wears glasses and has [REDACTED] hair. The suspect would be driving a black Toyota Rav SUV. HALL agreed that meeting with the police would be a good idea. Chief Shutes suggested he turn over all the evidence and speak to a police officer and a meet with the suspect could be set later to properly obtain all evidence needed for a successful prosecution. HALL stated that it was too late to cancel the meeting. He hung up on Chief Shutes shortly after this.

OFFICER ACTIONS:

On 12/2/2024 at approximately 1600hrs, officer Putman and I responded to the A&W at 628 N. Cedar Street to attempt to meet with HALL and to watch for a black Toyota Rav. HALL did not make contact with us and the suspect vehicle was not observed at that location. At approximately 1640hrs, we left A&W and turned over our vehicles to night shift.

I briefed night shift and Chief Shutes about the incident.

INFORMATION

On 12/2/2024 at 1700 hrs, I was dispatched to the Wilson Talent Center after [REDACTED] stated that he was touched inappropriately by the accused in the parking lot. Because [REDACTED] was [REDACTED] years old, Officer Washington contacted his father, who refused permission for the police to talk to his son.

CONTACT WITH SAMUEL HALL

I met with Samuel Hall at City Hall, who witnessed [REDACTED] conversation with the accused Hall stated that they started speaking with the accused on 11/25/2024 via the app Grinder.. [REDACTED] told the accused that he was 16 years old. During the conversation Hall stated that they had set up to meet with the accused at A&W 628 N Cedar St. on 12/2/2024. Hall stated that [REDACTED] told the accused that he was 15 years old not 16 and the accused stated that it was okay. Hall stated the accused got scared that the police were going to be there, so he changed the location to Harvey Education Center. Hall stated that the accused then changed the location a third time to the Wilson Talent Center. Hall stated when they arrived at the Wilson Talent Center, [REDACTED] walked over to the accused vehicle. The accused then got out of the vehicle hugged [REDACTED] and touched him inappropriately. The accused then shut the door and started to speed away. The accused made it to the end of the parking lot before [REDACTED] was let out of the vehicle.

FOLLOW UP WITH DETECTIVE BRIAN UZONI

I made contact with Deceive Brien Uzoni from the Livingston County Sheriff's Office. Detective Uzoni stated that the crime occurred in Livingston County, so they investigated the case. Uzoni stated that Swider was a youth pastor at one of the churches in Livingston County. Detective Uzoni stated [REDACTED] who was the victim told Swider that he was [REDACTED] years old. Detective Uzoni stated he was able to interview Swider and was able to get a statement from him. Soon after the interview Swider was fired from his job and fled to somewhere in Montana. Detective Uzoni stated they are currently pursuing charges on Swider and was advising us that [REDACTED] and his dad might be contacting Mason Police Department to file a kidnapping report from the incident that occurred on 12/3/2024.
