Hi Eric.

Thank you for your note. At this time, my wife and I have had poor experiences with multiple people in positions of leadership at CBC. We currently have little basis for trusting that this meeting would be handled properly, unfortunately. Therefore we are politely declining your request to bring our barely 13 year old son for a meeting with you and an attorney.

To be clear we are not bringing any allegations of serious/legal misconduct against Matt or the church. We do however firmly believe that a child shouldn't be expected to portray affections to an adult, no matter how chummy, and should not be asked to give account for how they respond to hugs and "I love yous." If further clarity is needed beyond this please let us know.

So while we are not comfortable with having the meeting as you've outlined/requested, we are also not sure where this leaves things relative to our original set of concerns shared with Steve Baker. You mentioned that those concerns are under review and being taken seriously, so we will wait to hear what next steps look like on that front from your perspective.
