On 08-13-25 Detective Birkeland requested that myself and Deputy Whitcomb attempt to locate a suspect in her case who was driving a white Chevrolet Malibu bearing MI: REG/ 7NEH48. We located the vehicle parked in front of [REDACTED] next to the garages and conducted a high risk stop. The suspect was subsequently taken into custody and transported to the DB for an interview without incident.

CONTACT WITH DETECTIVE BIRKELAND

I spoke with Det. Birkeland via tx who advised me that she and her team were [REDACTED] looking for a suspect involved in her case. She gave me a description of the vehicle we were looking for and a description of her suspect [REDACTED]

AREA CHECK/VEHICLE LOCATED

Dep Whitcomb and I drove to [REDACTED] from US 96 and Alpine Ave area and were advised via radio that his vehicle was in front of [REDACTED] garages. We approached from behind and located the suspect vehicle parked facing West next to the garages.

HIGH RISK STOP

Dep Whitcomb and I pulled behind the vehicle, activated our emergency overhead lights, drew our department

issued service pistols in a low-ready position, and began to give loud verbal commands. I ordered the driver to put his hands out of the window and advised dispatch that we had the vehicle. I ordered the driver to get out of the car, as he complied his vehicle began to roll forward. I ordered him to put his car in park, then Dep Whitcomb took over commands. As soon as he stepped out off the vehicle and continued to comply with commands, I holstered my Pistol.

USE OF FORCE

Dep Whitcomb and I completed a standards for this incident, EVT-00004866.

ARREST AND TRANSPORT TO KCSO DETECTIVE BUREAU

Dep Whitcomb arrested Thomas and searched him with negative results. Det. Birkeland requested that we transport Thomas to the DB for an interview, which he was without incident. Upon arrival to KCSO, Dep Whitcomb and I escorted Thomas to interview room 426 where we were met by Det. Saladino who then took custody of Thomas.
